Key element of the block grant is housing rehabilitation. Resolution authorizes to submit annual package.

Andrew Herlihy before the Council as City MassWorks Grants Administrator, Last before the Council was concerned about the issue relative to the MBTA plans to replace their bridge over South Elm Street and what that would mean with the pending MassWorks traffic improvements. Happy to report that thanks to the efforts of the Mayor, Council, and Legislative delegations they met with the MBTA, and the State allowed us to move our MassWorks Grant back one full year with no penalty. More importantly, the delegation was able to find money for the MBTA to move their project up by one year or more. This will allow us to both the traffic improvement work to support the Procopio-Beck project and replace the railroad bridge at the same time. The interagency cooperation has been extraordinary. One of the members of the team, Karl Eckstrom, has sent a letter and is available for technical questions. In order for the MBTA to go out to bid on this project, which they want to do in August—these are two separate projects; our MassWorks traffic improvement work and the MBTA's work—they will be going on in a coordinated fashion at the same time. In order for both projects to go out for bid, the MBTA needs to know the contractor has the permission from the Council to allow construction platforms to be built. Will build a construction platform over South Elm Street, two lanes of traffic will still be able to pass; will construct bridge over one year; new bridge will be replaced in one weekend. Need approval from Council to allow. Now have a bridge replacement schedule from MBTA. They will repair the under-bridge work as well. We can use MassWorks dollars on water, sewage, and drainage work in the area. Should be completed late 2024, early 2025.

Karl Eckstrom stated will set temporary bridge height well above existing bridge to allow for safe passage of all vehicles. The width of the road will remain the same with new bridge.

Councillor Bevilacqua asked if inflation will have an effect on the MBTA project? Stated it is the only opportunity to widen the road. Concerned about access for residents traveling and the safety during construction and will it be wide enough for two cars to pass?

Mr. Eckstrom stated current market conditions will increase the cost of the project, same project, same materials. Current market conditions increased cost but financially capable of handling increase. With regards to construction, will need to halt traffic when the steel is in the air suspended by the crane over the course of that single weekend. Once secure and stable traffic will allow to resume. Have done this at five other locations in 2021 and 2022. Will need two weekends of traffic interruptions. Stanchions will be placed wide enough and will shift lanes in order to accommodate to lanes of traffic.

President Barrett asked if any notification will be placed on the highway about construction? Andrew Herlihy stated he will look into possible signage on 495.

Mr. Steve Costa, Founder of Citizens for Haverhill Fire, addressed the Council urging that they reach back out to the delegation to see if can get additional funding for the temporary ladder truck to go to Station 4 on South Main Street due to the fact that neither city ladder trucks meet the weight restrictions for the Basiliere Bridge. In 2019, urged delegation for additional funding for a ladder truck to go to Bradford for the safety of our citizens in Bradford. Not one Council member posed this question.

President Barrett asked Andrew Herlihy to coordinate with Chief O'Brien to ensure fire ladder truck and any apparatus needed is on both sides. Andrew confirmed that they have been working on it.

Mike Katsulis, 118 South Elm Street, concerned that project will stretch into the sidewalks and street making vehicles cut the corners wider to the bridge.
