On motion of Councillor Sullivan to suspend the rules at the request of President Michitson to address status of the Merrimack Street/Goecke Parking Deck foundation and allow order to come forward for repairs. RULES SUSPENDED Yeas 9, Nays 0

President Michitson informed that he had received notification from a citizen about pieces falling in the deck and contacted Mayor Fiorentini who had the area immediately blocked off. Mike Stankovich, DPW Director, informed that the deck is over 40 yrs. old and over the last decade they have spent \$600,000 for repairs to concrete, lighting, fire suppression system. The East side is in pretty good shape, but West side has challenges with concrete spawning. The temporary repairs will be completed in 2/3 weeks. Mayor Fiorentini suggested that an engineering study be done and to make immediate repairs; RFP parcel as was suggested a few years ago in the UTILE study.
