City Council Minutes

Tuesday, November 17, 2020

Present – President Barrett, Councillors LePage, Michitson, Sullivan, Jordan, McGonagle, Daly O'Brien and Macek. Councillor Bevilacqua participated remotely.

President Barrett read the following statement: This meeting of the Haverhill City Council is being conducted remotely consistent with Governor Baker's Executive Order of March 12, 2020, due to the current State of Emergency in the Commonwealth due to the outbreak of the "COVID-19 Virus".

In order to mitigate the transmission of the COVID-19 Virus, we have been advised and directed by the Commonwealth to suspend public gatherings, and as such, the Governor's Order suspends the requirement of the Open Meeting Law to have all meetings in a publicly accessible *physical* location. Further, all members of public bodies are allowed and encouraged to participate remotely.

The Order, which you can find posted with agenda materials for this meeting allows public bodies to meet entirely remotely and live so long as reasonable public access is afforded so that the public can follow along with the deliberations of the meeting. This meeting will have hybrid – in person, virtual and call-in.

Due to the ongoing COVID-19 Pandemic, Governor Baker issued an Emergency Order temporarily suspending certain provisions of the Open Meeting Law, G.L. c. 30A sec. 20. Public bodies otherwise governed by the OML are temporarily relieved from the requirement that meetings be held in public places, open and physically accessible to the public, so long as measures are taken to ensure public access to the bodies' deliberations "through adequate, alternative means."

MR. DAN PLOURDE, SR., CHAIR OF VFW SANTA PARADE COMMITTEE, INFORMED THAT THE PARADE HAS BEEN CANCELLED AS WE KNOW IT DUE TO COVID 19. IN ITS PLACE THERE WILL BE A FOOD AND TOY DRIVE IN CONJUNCTION WITH THE HAVERHILL FIRE AND POLICE DEPARTMENTS AND ASSISTED BY THE BETSY CONTE FUND AND OZZIE'S KIDS COMMITTEE. THE FIRE DEPARTMENT WILL HAVE A FIRE TRUCK, WITH SANTA, DRIVE 30 MILES TO PICK UP UNWRAPPED TOYS AND FOOD AT 6 LOCATIONS. STAFF WILL TAKE ITEMS FROM CARS. EVERYONE IS TO REMAIN IN THEIR CARS. THE "PARADE" WILL START AT NOON. THE SIX LOCATIONS ARE ACADEMY PLAZA, TARGET, PENTUCKET LAKE SCHOOL, TILTON SCHOOL, PARKING LOT LOCATED TO THE RIGHT OF THE STADIUM AND BAILEY BOULEVARD. MR. Hearing was held on Document 104 – A communication from Christine Webb, City Tax Assessor, for Tax Classification Fiscal Year 2021, including related information and Orders. Ms. Webb gave a PowerPoint presentation. She informed that she has submitted her work to the Department of Revenue (DOR)

and they have reviewed and approved our new values and new growth. DOR has given them the go ahead to conduct tonight's public hearing in conformance with requirements of Chapter 369 of the Acts of 1982. Mayor Fiorentini informed that he had used \$2M in free cash to not lay off any employees. He would like to take a small portion from Free Cash, \$500,000 to help lower taxes and would like to change classification rate to 165. He is proposing to increase small business exemption from \$5K to \$7K; waive outdoor dining fee for upcoming year and waive renewal fees for liquor license renewal and reduce liquor license fees.
